- 2.2 The Company has received ballot forms up to 5.00 p.m. (IST) on 29th March, 2019, the last time and date fixed by the Company.
- 2.3 As on the date of this report, no envelopes containing postal ballot forms were received after 29th March, 2019, 5.00 p.m. (IST).
- 2.4 As on the date of this report, no envelopes containing postal ballot forms were returned undelivered.

The votes cast were unblocked on 29th March, 2019 at 05.05 p.m. (I.S.T) in the presence of two witnesses, Mr. Akshay Shah and Mr. Chandan Jha who are not in the employment of the Company.
